

## Adjudicated Newspapers in Kern County

Initial Fictitious Business Names (FBNs), FBN renewal with changes, and/or Abandonments must be published in the area where the business is being conducted. The publishing must occur once per week, for four consecutive weeks, with **one** of the adjudicated newspapers within **45 days of the filing date**. If the registrant does not have business in this state, the notice shall be published in a newspaper of general circulation in Sacramento County.

If the publication requirements<sup>1</sup> are not met the filing will need to be abandoned. If the person/entity decides to continue with the FBN they will **refile and publish** the new filing with the abandonment.
